

## Metformin Use: After A Cardiac Angiogram

During a cardiac angiogram, dye is injected and X-rays are taken. The dye may affect the way Metformin (Glucophage®, Glucophage XR®, Glucovance®, Janumet®) works. Here are the steps to take if you have had an angiogram and take Metformin.

*Do not take  
metformin for  
at least  
48 hours after  
your cardiac  
angiogram.*

- Do not take this medicine for at least 48 hours after your angiogram.
- Contact the doctor who manages your diabetes to develop a plan for caring for your diabetes through diet, other medications and blood sugar monitoring. Follow this plan.
- The Catheterization (Cath) Lab nurse will give you an order for a blood creatinine test. You may eat and drink before the blood test. Have this blood test done at least 48 hours after your angiogram. Please ask that the results be faxed to the Cath Lab at 312.926.5550. You can expect a call from the Cath Lab on the day the blood test is drawn with instructions about resuming your metformin. If you do not receive a call by 6 pm that day, please page the Cath Lab fellow at 312.926.CATH (2284).
- **It is important not to take Metformin until the Cath Lab nurse or doctor tells you to resume it.** Most patients may begin this medicine at least 48 hours after their angiogram.

Contact the doctor who manages your diabetes if there are any changes in your diabetes control.
